



## **TOWN OF LUNENBURG ACCOUNT PAYMENT OPTIONS**

The Town of Lunenburg offers a number of convenient account payment options. Electric, water, sewer and property tax payments may be made by:

- payment in person;
- mail payment;
- bank payment;
- telephone and internet banking;
- post-dated cheque; and/or
- pre-authorized payment.

### **Payment in Person**

You may pay your bill in person at the Lunenburg Town Hall, 119 Cumberland Street. Our payment office is located on the 1<sup>st</sup> floor of the Town Hall. Payment may be made in cash, cheque, money order, or debit. Office hours are Monday-Friday, 8:15 a.m. - 4:30 p.m. (holidays excluded).

We are pleased to announce that the Lunenburg Town Hall Cumberland Street level is now fully accessible. The accessible entrance is opposite the Firefighters Memorial. We have also installed an accessible payment counter to service all our customers.

### **Mail**

You may pay your bill by mail with a cheque or money order payable to the Town of Lunenburg. Please include your account information to ensure correct processing. Our mailing address is:

### **Bank Payment**

Payment may also be made at most Canadian banks and other financial institutions. Contact your branch for more information. To ensure payment is correctly processed, provide your bank with a copy of the bill.

### **Telephone and Internet Banking**

You may also pay through telephone and internet banking at most Canadian banks and other financial institutions. Contact your local branch for more information.

### **Pre-Authorized Payment**

- Pre-authorized bill payment will automatically pay your Town bills directly from your bank account. You can choose to pay the full balance of each bill when due or a monthly amount of your choice. Staff will be pleased to help you determine monthly budget amounts.
- This service is available for all Town Tax, Sewer, Electric and Water bills.
- Customers who wish to sign up for the service must complete a pre-authorized payment agreement available at the Town Hall Finance Office or visit us online to download the form at:

- Your monthly bills will still be mailed.

### **Post-dated Cheques**

The Town of Lunenburg will accept post-dated cheques payable to the *Town of Lunenburg*. Please include your account information on your cheque(s) to ensure your payment is posted to the correct account(s). Once received, post-dated cheques may not be cancelled.
